### ***First Friday...***

“There is a powerful energy in color. The conscious self is not aware that color is a world in which we live,” says Roger Hill, the painter, in answer to a question about the areas of movement and dynamic suspense that appear in his vivid paintings inspired by his observations of Wayne County countryside.

If Roger Hill the painter expresses his involvement in the world of color much like an avid gardener expresses his intense interest in the development of his plantings, it may be due to a concurrent stream of life in which he serves as manager of the Varcho Veda herb garden at the Himalayan Institute.

“Wayne County Colors,” a display of Roger Hill’s oil paintings and watercolors debuted for one night at Central Park Gallery on November 4. Gallery-goers feasted their eyes on Hill’s light-infused scenic dramas and their taste buds on apple cider pressed from the fruit of a hillside orchard that Hill manages. Three musical groups delighted attendees as they made their way through the gallery. In the early part of the evening Shannon Sexton sang accompanied by guitarist Dan Engvaldsen followed by a classical music mix by the Bethany Chamber Ensemble. A perfect evening of arts and enjoyment was brought to a close by musical duo, Roger Hill on guitar and new WCAA board member Ralph Liberto on saxophone.

What a great turnout for the final session of the 2005 Short Readings Series! Organizers and friends were sent scurrying to locate chairs for all the guests. Chairperson Frances Gruber, who had hoped that an unstructured evening would attract writers who desired to share their new completed works, was not disappointed. Among the offerings were a new, children's story by Pauline Glykokokalos beautifully read by Joan Hill; poems and a very honest and intimate essay narrated in a light-hearted manner about the experience of Gender Identity Disorder by one of our younger poets.

People congregated during the break, enjoying each other's company and sampling the refreshments. ## ***REVIEWS...***



### ***Better Half Dead...***

**A Play Written by Joan Torres and  
Performed by the Lakeside Players**

*(WCAA sponsored the November 5th production of the play.)*

Believability is not always a writer's highest priority. And why should it be? Would we have Richard Wagner's magnificent Ring Cycle, J.R.R. Tolkein's superb "Lord of the Rings", Frank Baum's beloved "Wizard of Oz" or J.K. Rowlings's magical "Harry Potter" series if their editors had demanded reality and realism?

On the other hand when a writer walks the edge between believable and highly improbable, it is up to the audience to cut them a break if they so wish, or crucify them for playing both sides of the fence. Joan Torres' play "Better Half Dead" is one such piece of writing. Its many convoluted plot twists could not help but leave the audience intoning a collective "Huh???" at the final curtain.

Forgoing plausibility, the play did manage to have a few good (and rightly deserved) jabs at a variety of sitting ducks, among them artists and the art world, land developers, trustee children and dysfunctional family types.

The Lakeside Players' production of the play made the best of a decidedly wacky script. Marylou Ambrose shone as the classically fragile 'new ager' hopelessly in love with the wrong guy. Roxanne Swartz played the self-centered, hardball bitch with style and verve. Tony Swartz's comedic agility brought an added pathos to the character of the pitifully inept, corrupt husband. Paul Podolsky's understated, sensitive portrayal of the family's gay lawyer was a delight and Marty Courtney's playing of the misguided artist/lover was well acted and convincing.

It was not a night to debate the script, but rather to sit back and enjoy the performance of a well rehearsed theatrical company whose attention to detail, timing and delivery was spot on. In an interview following the final show, Marylou Ambrose, co-founder of

Lakeside Players, commented that the play had brought in record attendance for the 7-year old company and that the cast had all agreed they were sorry when the play finished its run. "The plot was complicated and pulling it off wasn't easy. But we never had so much fun. We miss it", she said.

## My Book Report: War is a Force that Gives Us Meaning

*For this round, in honor of Veteran's Day I have selected Chris Hedges' War is a Force That Gives Us Meaning (Public Affairs, 2002).*

As a pacifist, one of the common phrases I hear with some regularity is "But no one wants war." Chris Hedges' book, at once enlightening and darkly disturbing, puts the lie to this canard. Hedges was a war correspondent, a veteran of conflicts in Bosnia and elsewhere, who came to realize that when he was away from conflict he missed it terribly – in fact, he loved it, craved it, was addicted to it. And he shows exactly how this addiction works - its effects on the psyche, and how humans try to rationalize those effects away, just as an alcoholic tries to maintain that "It's not a problem, I can handle it."

He documents, from his experiences, the exhilarating buildup to war, its devastating realities, and its equally (if not more so) devastating aftereffects. Hedges is not a pacifist, and says his goal is not to stop war but to understand it. Those of us who do seek to prevent war must understand what drives the people who (secretly or not) love it.

And by the way - we in the peace community have to understand that Hedges is talking about us too. We also feel, don't we, the exhilaration of finding an enemy deserving of attack and entering into confrontation with that enemy. Even though we might call our approach nonviolent, we have to beware that war's charms do not warp our psyches as well.

One of the reviewers of this book on Amazon.com, a Dr. Mark Goulston, is a therapist among whose patients are many veterans. I will close with the words of one of those patients, who summarized war as "the seducing, using, and in the end discarding of young men to wage a battle between the egos of older men who in the name of God desperately try to hold onto power they never deserved to have in the first place."

That sounds about right to me.
